Suggested Specification

Model P8ACEE shall deliver 8.0 gph of 50° F degree water at 90° F ambient and 80° F inlet water. Model P8ACEE shall include an infrared sensor to activate the flow of water. Basin shall be designed to eliminate splashing and standing water. Bubbler shall have flexible guard and operate between 20 and 120 PSI. Cabinet finish shall be Sandstone or Greystone powder coated paint on steel or brushed stainless steel. Cooling system shall use R-134a refrigerant. Shall comply with ANSI A117.1 and ADA. Shall be listed by Underwriters' Laboratories to U.S. and Canadian standards. Shall comply with ANSI/NSF 61.

Model

P8ACEE produces a light beam that is reflected off the user to automatically start water flowing. Not even a touch is needed. If user does not move away within 30 seconds, water shuts off automatically. This model satisfies CABO/ANSI A117.1 and complies with ADA requirements when properly installed. Model also meets guidelines for children's accessibility providing the floor to orifice height is 30 inches and proper clear floor space is provided for frontal approach.

Export Warranty: One year on component parts. Detailed warranty certificate enclosed with each drinking fountain; sample copy available upon request.

Product Certified to NSF/ANSI Standard 61, Annex G (weighted average lead content of <=0.25%) and is in compliance with California's Health & Safety Code Section 116875 (commonly known as AB1953).
